T4; Holm Oak and Sycamore (on western boundary) – Reduce side to clear magnolia. T5; Decayed Holm Oak stem near gazebo – Remove. T6; Turkey Oak near cottage – Lift canopy by 2-3m, reduce eastern side of canopy to clear roof by 2m. Holm Oak – Lift canopy by dinghies to 8ft.
