Public: There were 2 members of the public both of whom made observations and asked questions.

The cut-through by the bus stop to Harbour Strand has a set of steps that are very dark – could any lighting be installed? The PC noted this request.

The rubbish bin in the car park by the Palmer Memorial is often over-flowing. Please could there be a bigger bin here? The PC have tried before but note the need. It is IRs responsibility.

There appears to be drug dealing around Crossways, the cemetery, park and windmill all seem to be favoured locations. The local police officer is aware but the PC will reinforce this.

Can the RoW near Warner's Hotel and the boardwalk be improved and brambles cut back (Footpath BB42)? This is IRs again and our lengthsmen are very busy right now but we will ask them to have a look and do the worst to make it clearer for pedestrians.
